- The Summerville Commissioners of Public Works maintenance responsibility ends at the property or easement line.
- If service is not available to the property, extension or installation of service lines shall be completed at the applicant's expense. The applicant may use a private contractor or request an estimate of time and cost from the Summerville Commissioners of Public Works. The cost for any work performed by the Summerville Commissioners of Public Works will be estimated prior to any work being initiated. Any costs incurred during construction due to unknown obstructions or field conditions shall also be borne by the applicant. The final cost of any work performed by the Summerville Commissioners of Public Works shall be paid prior to water/sewer service being provided to the property. Service may be discontinued for nonpayment of the Summerville Commissioners of Public Works costs.
- To provide a 24 hour notice when requesting a sewer tap inspection.
